# Changes due to COVID-19

# Health Fee Versus Health Insurance

## Health Fee

- Mandatory; paid with tuition
- \$172/semester Fall and Spring semesters
- Covers most care at Stamps
- Unlimited visits with provider in Primary Care and Women's Clinic
- 3 hours of care (6 visits) in Psychiatry
- Procedures done in Primary Care
- Some In-house labs

## Health Insurance

- A Student Health Insurance Plan (SHIP) with United Healthcare is offered by GT
- Optional for most undergraduates
- Mandatory for some students (GRA's and GTA's, J1 and F1 visas, some programs)
- Covers care that occurs outside of Stamps
- Can be used for medications at Stamps Pharmacy

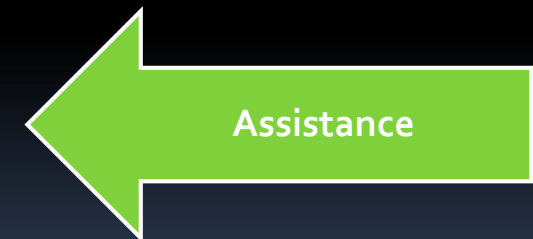

# Student Health Insurance Plan

**Open Enrollment** is **7/26/2021-9/20/2021**. You must enroll yourself and your eligible dependents under the mandatory plan twice a policy year (Fall and Spring/Summer).

## **Policy Effective Dates:**

**Fall:** 08/01/2021 through 12/31/2021

**Spring/Summer:** 01/01/2022 through 07/31/2022

# Student Health Insurance Plan

- The changes and important details for the 2021-2022 Academic Year for Georgia Tech students are as follows (effective starting Aug. 1):

- The annual individual deductible and the out-of-pocket maximum will increase.

Annual individual in-network deductible-\$250 to **\$500**

Out-of-pocket maximum- \$3,750-**\$6,350**

- International students at Georgia Tech cannot waive with **PGH or any non-ACA compliant plan**. They must either enroll in the Mandatory SHIP or waive with an ACA-compliant plan.

# Student Health Insurance Plan

## COVID-19

- 1. Virus detection and antibody testing:** Cover medically necessary COVID-19 testing at no cost-sharing (copayment, coinsurance or deductible) when ordered by a physician or health care professional for purposes of diagnosis or treatment of an individual member through the national public health emergency period.
- 2. COVID-19 testing-related visits:** Waiving cost-sharing for COVID-19 testing-related visits through the national public health emergency period whether the testing-related visit is received in a health care provider's office, urgent care center, emergency department or telehealth visit.
- 3. COVID-19 treatment:** Waiving member cost-sharing for the treatment of COVID-19 the national public health emergency period.
- 4. All other related care** (e.g., hospitalization) will be covered as any other sickness or illness at no cost-sharing the national public health emergency period.
